

INFORMATION pursuant to Art. 13 GDPR Regulation (EU) 679/2016

RB Distribution s.r.l. guarantees compliance with the regulations governing the protection of personal data, and with reference to the data you provide, wishes to inform you of the following:

A. Data Controller

B. Data processed, purpose and legal basis for processing

The personal data you provide (personal, contact, tax and bank details) are processed for the following purposes:

- a) execution of pre-contractual measures (preparation of a quote) and for the subsequent conclusion and execution of the contract, where applicable;
- b) administrative purposes and the fulfilment of legal obligations - such as, for example, those of an accounting and tax nature - deriving from any contract entered into (issue of invoices, management of payments);
- c) the e-mail address may also be used for the sending of occasional commercial communications;
- d) compliance with any requests from the legal authorities;
- e) exercise of any rights in court, administrative and out-of-court proceedings. The

legal bases for processing are:

- article 6(1)(b) GDPR - performance of a contract to which the data subject is party or for the execution of pre-contractual measures at the request of the data subject, for the purpose referred to at letter a),
- article 6(1)(c) GDPR - compliance with a legal obligation to which the Data Controller is subject, for the purpose referred to at letters b) and d),
- art. 6(1)(f) GDPR - a legitimate interest pursued by the Data Controller, for the purpose referred to at letters c) (transmitting information regarding products and training courses) and e) (protection of rights and legitimate interests).

C. Nature of conferment

Providing your data is optional, but refusal to do so will make it impossible to process your request for a quote or to conclude the contract (sale of our products and/or participation in our courses). You can provide your data by creating your personal account on the www.homm.net website, by e-mail, via our agents or at the store.

D. Processing methods and data retention periods

The data collected will be processed using electronic, IT and computerised means, or manually, in ways strictly related to the purposes for which the personal data were collected and, in any case, in order to guarantee the security of the same.

All data will be kept for the time strictly necessary to manage the purposes for which the data are collected, in accordance with the applicable regulations and legal obligations, and in any case for a period not exceeding ten years from your last purchase or the last training course you attended.

E. Data Communication

The data collected is processed by our internal staff.

The data collected may be communicated to all those subjects that provide services connected with and instrumental to the above-mentioned purposes (banking institutions for payment management, companies that deal with the maintenance of computer systems, external professionals - accountants, lawyers, etc.) and legal or administrative authorities, for the fulfilment of regulatory obligations or orders of the authorities.

In any case, personal data will never be disclosed or transferred to third countries.

F. Rights of the data subject

We inform you that you are entitled to the rights provided for in the following articles of the GDPR Reg. (EU) 679/2016:

- *Article 15 - Right of access by the data subject* (to obtain access to their own personal data and information related to them),
- *Article 16 - Right to rectification* (to obtain the rectification of inaccurate data or completion of incomplete data),
- *Article 17 - Right to erasure ('right to be forgotten')* (to obtain the deletion of personal data),
- *Article 18 - Right to restriction of processing* (to obtain the restriction of processing in one of the cases indicated in art. 18(1) of the GDPR),
- *Article 20 - Right to data portability* (where the legal basis of the processing is a contract or consent, and the processing is carried out by automated means, to obtain personal data in a structured, machine-readable format, also for the purpose of communicating such data to another data controller),
- *Article 21 - Right to object* (to object at any time to the processing of their personal data in the event of a special situation concerning the data subject),
- *Article 77 - Right to lodge a complaint with a supervisory authority* (Data Protection Authority) - www.garanteprivacy.it.
